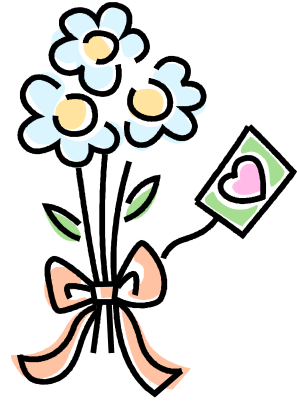
The Summer Board Session for dreaming and goal-setting will be held Thursday, July 25th, 10am - 1pm, at the home of Tina Caliga.

Fundraising Distributions

The income after expenses from all our fundraisers and related donations in the fiscal year 2012-13 stands at **\$8,526.23**. In June, Treasurer Peggy Harwood made the following distributions:

- 35% to Tarrant County College Scholarships, **\$3,044.18**
- 30% to the AAUW Educational Opportunities Fund, **\$2,767.87**
- 10% to the AAUW Legal Advocacy Fund, **\$852.62**
- 10% to Leadership Training and Conventions, **\$852.62**
- 10% to the Sister to Sister Summit, **\$852.62**
- And 5% is retained for Administrative Costs in next year's budget, **\$426.31**.

47th AAUW National Convention **Breaking through Barriers: *Leading across Generations*** **Eye Witness Report from Tina Caliga**

Attending the 47th AAUW National Convention in New Orleans was a very exciting and energizing experience for me. I have prepared this summary of presentations by the key speakers to share what I learned with the AAUW-TCB branch members and friends. I also wish to express my sincere appreciation for the opportunity to attend and represent our branch.

Opening Ceremonies – Monday, June 9

Jackie Clarkson, President of the New Orleans City Council, welcomed us to New Orleans and gave an update on the city, post-Katrina. She said they have re-established quality education in the city. Women now fill 6 out of 7 seats on the New Orleans City Council.

Carolyn Garfein, AAUW President, presented an **Update on AAUW:**

- The 2009 Governance change to a 501(c)3 nonprofit organization and consolidation into one Board of Directors has paid off reputationally. AAUW now has an excellent rating and is in the top five US charity organizations.
- In 2009, AAUW national changed to One Member One Vote. Since then AAUW has become a leader in the use of social media, Facebook, the Two Minute Activist, Get out the Vote, and effective in getting voters out on issues.
- AAUW has experienced a membership turnaround, with steadily increasing membership, through social media and the Action Network. We now have 165,000 plus members & supporters, over 1000 branches, and 813 college and university partners, up from 718 in 2008.
- The National Council of College Women Student Leaders (NCCWSL) met in early June with 700 college women participating.
- Start Smart Salary Negotiation Workshop is now held on 200 campuses per year.

- Elect Her for campus women has been adding 10 campuses each year, held on 50 this year.
- Tech Trek Summer Camp for eighth grade girls is expanding from California with pilots into several other states.
- The Tech-Savvy: Educating Girls in the new Computer Age program, founded by the Buffalo, NY Branch in 2011, has been so successful that the sponsor Praxair is funding an expansion to 10 new sites next year.
- AAUW is acclaimed worldwide for its research. The latest report, out April 30, is entitled “Women in Community Colleges: Access to Success.”
- This year we celebrate 125 years of women’s scholarships with over \$4.3 million in fellowships and grants being awarded to support 278 women in their professional and academic careers.
- AAUW is involved in a number of international projects with women in Israel, China, Cuba, and South Africa.
- AAUW is a strategic partner with the Clinton Global Initiative/University 2013.

Monday Afternoon Panel Discussion - “Equal Pay 50 Years Later”

Linda Hallman, AAUW Executive Director, introduced the panel:

- **Lilly Ledbetter**, author of Grace and Grit, namesake of the 2009 Fair Pay Act
- Keith Hill, Director of the New Orleans Field Office of the U.S. Equal Employment Opportunity Commission (EEOC)
- Linda Maatz, AAUW Director of Public Policy and Government Relations

Lilly Ledbetter said, “My story is not unique, it is just the tip of the iceberg!” Linda Maatz stated that AAUW has asked President Obama to continue working on Equal Pay and to consider using an Executive Order, if Congress does not pass the Paycheck Fairness Act. There is a new Whitehouse.gov portal on equal pay.

Why is there a pay gap for women?

1. The majors chosen in college and types of jobs women work;
2. With parenthood, wages go up for men and down for women;
3. Choices made for us, jobs not offered, raises not given, based on discrimination, beliefs, and gender stereotypes that die hard.

There has been virtually no change in the last decade, just 1% improvement. The new Paycheck Fairness Act being considered in Congress will tighten loopholes, move the ball down the field, and update the 50 year old bill. Women need their comparable work to be valued equally with men. AAUW has a new self-help website for people who think they have been discriminated against. The AAUW Lobby Corps is now a fixture in Congress. AAUW Public Policy Impact Grants are open to all 50 states. The \$mart \$tart program teaches college students to negotiate higher starting salaries.

Tuesday Morning, June 11

Keynote Speaker Robin Gerben delighted the audience using storytelling to present “Leadership the Eleanor Roosevelt Way.” Gerben is a historian and author of the book by the same title on the former First Lady. She told stories and shared quotes from Eleanor’s childhood through old age. During her time Eleanor received extreme criticism from many, while her greatest causes were civil rights, women’s rights and education. She was the most admired woman in the world when she died in 1962. The twelve chapter book would provide a great roadmap for studying lessons in leadership.

The AAUW Eleanor Roosevelt Award for 2013 was presented to Linda Alepin for her work as chair and founder of the Global Women's Leadership Network. This is a nonprofit leadership development and community resource for women leaders around the world.

Tuesday Afternoon - Annual Meeting

Carolyn Garfein, AAUW President, led the Annual Meeting, highlighting the accomplishments of the past two years. She invited a representative of each national committee to the podium to share their top two accomplishments.

The Membership Committee informed us of 10 new branches, including 3 virtual and 3 college branches. There are new resources for recruitment, and to encourage diversity and inclusion. Improvements have been made to the Member Database.

The Branch Program Resources Committee Chair spoke of their work identifying successful branch programs. They have streamlined and developed a support base for their mission-based programs and "Programs in a Box."

The STEM Taskforce Committee Chair shared information that grants have enabled the expansion of Tech Trek Camps into Florida, Ohio, Texas, and Washington.

Lisa Maatz, AAUW's top policy adviser, spoke of the "Get out the Vote" campaign and their work for Pay Equity. Online visits to their blog are up 66%.

The College and University Relations Committee Chair said AAUW has the highest number of CU Partners to date, 813. There are 200 new CU Partners. E-Student memberships are up to 4,000.

Mike Gellman, AAUW's Chief Financial Officer, spoke on the strong financial position of AAUW investments and new working rules for the Investment Committee.

Jill Birdwhistell, AAUW Chief Operating Officer and Chief of Strategic Advancement, spoke of the AAUW "Crossing the Line Report" and \$100,000 dedicated to recent LAF cases. LAF has supported the plaintiffs in the unsuccessful Wal-Mart lawsuit as well as three military sexual abuse lawsuits.

Suzanne Gould has been hired as the fulltime AAUW Archivist and Records Manager to preserve AAUW history. So far she has worked through 42 of 700 boxes of AAUW memorabilia. Gould described finding the thank you letter from Rachel Carson for the AAUW grant to fund her research for The Silent Spring.

Gloria Blackwell, Director of Fellowships & Grants, reported that \$4.3 million have been granted to 278 people and programs in 2013. The AAUW Annual Achievement Award has been re-instated, this year being awarded to Sen. Olympia Snowe.

Dr Catherine Hill, AAUW Director of Research, spoke on a new research report just out on "Women in Community Colleges." AAUW Research reports are available on the web with Power Points presentations. AAUW provides annual updates on "The Simple Truth About the Gender Pay Gap."

AAUW Director of Campus Leadership Programs, Kate Farrar, reported accomplishments in the development of campus leadership through the National Conference for College Women Student Leaders (NCCWSL), which had 700+ participants this year. A pilot is underway with Mentor Cloud.

Tuesday Evening Banquet

Senator Olympia Snowe was recipient of the 2013 AAUW Achievement Award. She spoke on the *equity imperative for women*. Snowe retired from the Senate in January, 2013. She championed many initiatives during her years in public office, including establishing the Office of Research on Women's Health. She is the third longest serving woman in the history of Congress, as well as the first woman to serve in both houses of her state legislature and then both houses of Congress. In 2006, in *Time* magazine, she was named one of the top 10 U.S. Senators. While in Congress Snowe worked to build bipartisan consensus on many issues and built a reputation as a leading moderate. She was a wonderful and inspiring speaker!

Wednesday Morning, June 12

Keynote Speaker Cynthia D'Amour presented "How to Get Beyond "We've Always Done it That Way." " After the many workshops and new ideas we had learned, this was just the exercise needed on how to present and incorporate new ways of doing things in our branches when we return home.

Closing Ceremonies

Out-going President Carolyn Garfein spoke on her journey in AAUW, saying she "joined for the mission and stayed for the friendships." She found in AAUW "an instant community of women with shared values." She passed on a Dr. Seuss book *All the Places You'll Go* to incoming President Patricia (Pat) Ho.

In-coming President Pat Ho began by quoting Bill Nye: "Everyone you will ever meet knows something you don't." She spoke of the learning and sharing we all had at convention. She said AAUW has goals and direction working for us. We want to be smart, strong, and bold. We will strengthen our support of branches and colleges, while we reach out to young student leaders. She outlined the goals of the new board of directors, including continuing wise use of resources and maintaining a good financial position, working globally, pursuing collaborations and partnerships, and expanding our horizons.

The Convention concluded with the announcement of the 48th Convention being planned for San Diego, CA, at the Sheraton San Diego Hotel and Marina.
