Lobbyist information from 87th Texas Legislature Jan 5 to May 31, 2021

Introduction; This report is a categorization of bills which AAUW Texas supported or opposed during the regular legislative session. It has been compiled from Kevin Stewart's bill tracks and notes from periodic meetings with him. Numerous **supported bills** will be identified first, while the **opposed bills** will appear at the end of the report.
